Reversal signals?

VN30 performance

The VN30-Index continued its upward momentum for the second consecutive session, rising by 0.56% to reach 1,335 pts. Buying interest was seen in stocks such as VIB (+2.74%), HDB (+2.44%), and BCM (+2.14%). On the other hand, only seven stocks closed in the red with adjustments below 1%.

VN30 Future chart: Reversal signal?

On the daily chart, the downtrend may reverse as the Harami candlestick pattern was confirmed by yesterday's upward session. Increasing liquidity also suggests confirmation of this recovery. However, it is still too early to conclude that an uptrend has returned, as trading volume remains low compared to previous sessions.

On the hourly chart, the contract showed accumulation within the 1,335-1,339 point range. A breakout signal is required to confirm the next trend.

Technical strategy

The downtrend may reverse following yesterday's increase. However, it is still too early to assume that an uptrend will return in the near term, as technical indicators continue to imply a downtrend. Therefore, traders should wait for additional signals before opening long or short positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




