High demand at afternoon session

VN30 performance

The VN30-Index returned to a bearish trend, decreasing by 0.14% to 1,333 pts. Selling pressure appeared in stocks such as VHM (-3.74%), SSI (-1.31%), PLX (-1.19%), and VNM (-1.04%). Meanwhile, cash flow was seen in STB (+2.20%), VIB (+1.33%), and TCB (+1.05%).

VN30 Future chart: High demand at afternoon session

On the daily chart, the contract continued its third consecutive session of growth. The appearance of a candlestick with a long lower shadow indicates cash flow support for the current uptrend. Additionally, volume shows an upward trend, suggesting a positive outlook for recovery. However, it remains too early to conclude that the downtrend has ended, as the index still closes below short-term moving averages.

On the hourly chart, a long-bodied green candlestick in the late session implies a short-term intraday reversal. However, further confirmation signals are needed to suggest that an uptrend has returned.

Technical strategy

The signals are currently inconsistent, so it is still too early to conclude that an uptrend will return. Therefore, investors should wait for additional signals before opening long or short positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




