# **Caution ahead of the U.S. Election**

## VN30 performance

After two adjustment sessions, the VN30 Index experienced growth, but the increase was insignificant, reaching only 1,313 pts. Cash flowed into stocks like GVR (+1.74%), SHB (+0.96%), and POW (+0.87%). Conversely, selling pressure emerged on stocks such as CTG (-1.82%), BID (-0.63%), and VJC (-0.48%).

# VN30 Future chart: Caution Ahead of the U.S. Election

On the daily chart, the contract shows caution with the formation of a candlestick with a small body. Additionally, there was a sharp decline in volume, implying investor caution ahead of the U.S. presidential election.

On the hourly chart, the contract similarly shows signals of limited volatility. Although the contract attempted to break out in the afternoon session, it failed. Therefore, more signals are needed to confirm the upcoming trend.

# **Technical strategy**

The contract demonstrates short-term caution as the price fluctuates within a narrow range and volume declines significantly. Therefore, traders should be cautious and await further signals to confirm the trend.



Figure 1. VN30 Generics daily chart










#### Figure 4. Open interest pattern




