Selling pressure?

VN30 performance

The VN30-Index recorded its second consecutive adjustment session as the level of decline increased. Accordingly, selling pressure emerged on stocks such as VHM (-3.38%), CTG (-1.69%), and VIC (-1.56%). In contrast, only four stocks showed growth such as BVH (+2.85%), FPT (+0.52%), VJC (+0.29%), and HPG (+0.19%).

VN30 Future chart: Selling pressure?

On the daily chart, the contract re-tested the 1,320-point range, with selling pressure slightly increasing in the final session of the week as trading volume rose slightly. Additionally, the index dropped below the 10-day and 50-day moving averages, indicating a negative signal returns. Therefore, it is possible that the index has confirmed a short-term downtrend.

On the hourly chart, while the contract formed a pattern similar to a Hammer in the final candlestick of the last session of the week, suggesting a demand increase at the end of the session as the 1,320-point range was tested, this pattern has yet to be confirmed by a subsequent green candlestick. Thus, further confirmation signals are still needed in the upcoming session.

Technical strategy

The downtrend regained the upper hand as the contract closed below most of the critical moving averages. Therefore, traders should carefully observe the next trend to make suitable investment decisions.



Figure 1. VN30 Generics daily chart




Figure 2. Basis spread





Figure 4. Open interest pattern




