

Short-term downtrend

VN30 performance

The VN30-Index underwent its fourth consecutive adjustment session, declining by 0.65% to 1,301 pts. Accordingly, selling pressure emerged on stocks such as MWG (-3.49%), GVR (-1.50%), MSN (-1.36%), and CTG (-1.29%). In contrast, only five stocks showed growth, with SAB being the only stock to grow by more than 2%.

VN30 Future chart: Short-term downtrend

On the daily chart, the contract confirmed the adjustment trend with its fourth consecutive adjustment session. The continued increase in volume suggests a negative outlook, confirming the downtrend. Additionally, the contract closed below most of the key moving averages. Therefore, the Hammer pattern that had formed in the previous session has failed, and the downtrend is expected to continue.

On the hourly chart, a Tweezer Bottom pattern has formed with a corresponding increase in volume, suggesting a reversal signal. However, an additional growth session is required to confirm the return to an uptrend.

Technical strategy

Although a Tweezer Bottom pattern has formed on the hourly chart, the contract has not yet confirmed this reversal signal. Therefore, traders should carefully monitor the next trend to make appropriate investment decisions.



Figure 1. VN30 Generics daily chart






Figure 2. Basis spread






