Awaiting a breakout signal

VN30 performance

After three adjustment sessions, the VN30-Index recorded a growth session, but the increase was negligible as it closed at 1,336 pts. The stocks in the VN30-Index basket showed divergence, with the number of gaining and declining stocks being nearly equal. Specifically, selling pressure appeared on POW (-1.98%), BCM (-1.47%), MWG (-1.32%), VCB (-1.27%), and VRE (-1.14%). On the other hand, buying momentum was seen in SHB (+2.42%), HDB (+1.07%), and FPT (+0.67%).

VN30 Future chart: Awaiting a breakout signal

On the daily chart, the contract continued to exhibit caution as it formed a candlestick with a small body and long upper and lower shadows. This reflects investors' cautious sentiment. Additionally, trading volume remained low, implying a short-term accumulation phase is taking shape.

On the hourly chart, the contract accumulated within the range of 1,335-1,347 pts, forming a rectangle pattern. The contract still requires a breakout signal on either the upper or lower boundary to confirm the intraday trend.

Technical strategy

The contract formed an accumulation phase within the range of 1,335-1,347 points on the daily chart. A breakout signal to confirm the next trend is necessary. Based on this signal, investors can open long or short positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




