# **Continued caution**

## **VN30** performance

The VN30-Index recorded a session of correction, though the adjustment was not significant, closing at 1,335 pts. Specifically, selling pressure was observed in PLX (-1.25%), VIC (-0.97%), and SHB (-0.94%). On the other hand, buying momentum appeared in BVH (+1.34%) and HDB (+1.27%).

### **VN30 Future chart: Continued caution**

On the daily chart, the contract continues to show caution, forming a candlestick with a small body and a long upper shadow. This reflects the cautious sentiment of investors. Additionally, trading volume remains low, implying the formation of a short-term accumulation phase.

On the hourly chart, the contract is accumulating within the 1,335-1,350 range, with increasing amplitude, forming a rectangle pattern. The contract still needs a breakout signal either above or below this range to confirm the session's trend.

# **Technical strategy**

The contract formed an accumulation phase within the 1,335-1,350 range on the hourly chart. A breakout signal is essential to confirm the next trend. Based on this signal, investors can consider opening long or short positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




