VN30 performance

After two previous correction sessions, the VN30-Index recorded a growth session, though the increase was not significant, reaching 1,331 pts. Cash inflows tended toward VNM (+1.25%), POW (+1.22%), and SSI (+1.16%). On the other hand, selling pressure appeared in BVH (-1.69%) and HPG (-0.74%).

VN30 Future chart: Low liquidity

On the daily chart, the contract continues to show caution with a candlestick characterized by a small body and long wicks. Trading volume remains low, indicating that investors are still hesitant about the current trend. Over the past 7 sessions, the market has been forming a Flag pattern, a type of consolidation pattern. To confirm the next trend, a breakout session is required.

On the hourly chart, the contract trades within a range of 1,329–1,337 points. This range signals a consolidation phase. Therefore, a breakout signal is necessary to open new positions.

Technical strategy

The contract continues to form a consolidation phase. Therefore, a breakout signal to confirm the next trend is essential. Based on this signal, traders can open either long or short positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




