Awaiting a breakout signal

VN30 performance

The VN30-Index returned to a downtrend as selling pressure increased. Accordingly, the index declined 0.31% to 1,327 pts, with selling pressure observed on FPT (-1.27%) and MWG (-1.15%). On the other hand, only 5 stocks advanced, with buying interest concentrated on VHM (+0.85%) and PLX (+0.52%).

VN30 Future chart: Awaiting a breakout signal

On the daily chart, despite a corrective session, the contract still shows caution by maintaining the previous candle's range. The trading volume remains low, indicating that investors are still hesitant about the current trend. Over the last 8 sessions, the market has been forming a flag pattern, a type of accumulation pattern. To confirm the next trend, a breakout session is necessary.

On the hourly chart, the contract expanded its trading range between 1,329-1,337 pts, marking an accumulation phase. Therefore, a breakout signal is essential to open new positions.

Technical strategy

The contract continues to form an accumulation phase. Therefore, a breakout signal to confirm the next trend is necessary. Based on this signal, investors can open long or short positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




