# **Negative signals**

### **VN30** performance

The VN30-Index continued its fourth consecutive correction session as selling pressure emerged in the afternoon session. Consequently, the index dropped 0.57% to 1,313 pts. Among the component stocks, 10 declined by more than 1%, with notable pressure on stocks such as MSN (-3.59%), GVR (-2.97%), MWG (-2.73%), SAB (-2.55%), and BVH (-2.51%). On the other hand, buying demand was seen in some banking stocks, including BID (+1.57%), VCB (+0.98%), and SHB (+0.49%).

### **VN30 Future chart: Negative signals**

On the daily chart, the contract recorded its second session closing below short-term moving averages, signaling a negative trend for the market. Additionally, liquidity remained high compared to the previous period, indicating that a downtrend has been established.

On the hourly chart, the contract closed below the 50-period moving average, and the 10- and 20-period moving averages also crossed below it. This serves as confirmation that the downtrend is likely to continue. The support level for the next session is around 1,310 pts.

#### **Technical strategy**

The contract has confirmed the correction trend, with selling pressure evident in the last two sessions. Therefore, traders may consider waiting for a intraday rebound to open short positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




