# **Bearish signal**

### **VN30** performance

The VN30Index recorded its fifth consecutive correction session, declining by 0.73% to 1,363 points. Among the 30 constituents, 12 stocks posted a decline of more than 1%, notably GVR, which hit the floor price. Other stocks also faced selling pressure, including BCM (-3.61%), MSN (-2.48%), and FPT (-2.42%). On the other hand, demand emerged primarily in MBB (+0.84%), TPB (+0.70%), and VNM (+0.50%).

#### VN30 Future chart: Bearish signal

On the daily chart, the futures contract registered a second breakout session as it dropped below the 1,370-point level. This once again confirms the previously formed double-top pattern. Trading volume picked up during the session, reinforcing the bearish signal.

With confirmation of the double-top pattern, the downside target for the contract is expected to be in the 1,340-1,350-point range. This area also serves as a strong support zone at the current stage of the downtrend and aligns with the 50-period moving average.

#### **Technical strategy**

The contract has confirmed a double-top pattern, with a correction target in the 1,340-1,350-point range. As such, traders may consider opening short positions in the upcoming trading session.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




