# **Divergence during the session**

## **VN30 performance**

The VN30-Index ended the session nearly flat, closing at 1,376 points. Capital inflows were directed toward SSI (+1.54%), FPT (+1.24%), and VIC (+1.17%). On the other hand, selling pressure emerged in SSB (-1.79%), BVH (-1.14%), STB (-1.13%), and MBB (-1.02%).

## VN30 Future chart: Divergence during the session

On the daily chart, the contract continued its second recovery session, supported by the 50-period moving average. However, liquidity remained low. This suggests that the current rebound may be a bull trap.

In addition, the contract has yet to reach the target price of the previously confirmed double-top pattern (in the 1,340-1,350 range), indicating that the downtrend is likely to resume in the upcoming sessions.

## **Technical strategy**

The contract continues to confirm the double-top pattern, with a corrective target in the 1,340-1,350 range. As such, traders may consider opening short positions in the upcoming trading session.



Figure 1. VN30 Generics daily chart






Figure 2. Basis spread

#### Figure 4. Open interest pattern




