Sharp drop in liquidity

VN30 performance

Following four consecutive sharp correction sessions, the VN30-Index recorded an impressive rebound, rising 6.90% to 1,249 points. The surge came after President Trump announced that the U.S. would impose only a 10% reciprocal tariff on countries (excluding China) and delay enforcement by 90 days for negotiation. As a result, all index constituents hit their ceiling prices.

On the daily chart, the futures contract posted a strong gain and formed an intraday gap. Low liquidity was due to limited supply from sellers. However, these signals are not yet sufficient to confirm an uptrend, as market volatility remains high. Additional confirmation is needed before a trend reversal can be established.

The 1,300-point level will act as a strong resistance in the next session, while the 1,100-1,150 zone remains a key support area.

Technical strategy

Despite the strong rebound, volatility continues to rise sharply. As such, traders should remain cautious, monitor market developments closely, and carefully time their entry for new positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




