# **Momentum slowed?**

## **VN30** performance

The VN30-Index recorded its third consecutive gaining session, rising 1.55% to 1,241 points. However, market breadth remained narrow as buying demand focused mainly on MWG, VHM, and VIC — all of which hit their ceiling prices. On the other hand, selling pressure concentrated on SSB (-4.25%), PLX (-1.41%), TPB (-1.14%), VNM (-1.04%), and LPB (-1.02%).

#### **VN30 Future chart: Momentum slowed?**

On the daily chart, the contract continued to recover and broke above the 10-period moving average, providing a short-term positive signal. However, these signs are not yet sufficient to confirm an uptrend, as market volatility remains high. Additionally, the pace of gains has slowed compared to previous sessions.

The 1,350-point level will act as strong resistance in the upcoming session, while the 1,200-point range remains a key support zone.

### **Technical strategy**

Despite three consecutive recovery sessions, volatility remains elevated. As a result, traders should stay cautious, closely monitor market developments, and carefully assess the timing for entering new positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




