# **Short-term caution**

### **VN30** performance

The VN30Index returned to a corrective phase after two previous gaining sessions, declining 0.91% to 1,294 points. Selling pressure focused on VIC, which hit the floor price. Other stocks such as GVR (-3.27%), VJC (-2.89%), LPB (-2.51%), and BVH (-2.22%) also faced strong declines. In contrast, buying interest appeared in STB (+4.93%), SHB (+2.72%), TPB (+2.65%), and BCM (+2.22%).

#### **VN30 Future chart: Short-term caution**

On the daily chart, the contract moved upward but stayed within a narrow range of 1,285-1,320 points. This reflected investor caution.

A breakout above or below this consolidation range is required to confirm the next trend. The 1,330-1,350 zone acts as strong resistance, while the 1,200 level serves as solid support.

#### **Technical strategy**

The contract trades within the 1,285-1,320 range. A breakout signal is needed to confirm the next direction. Traders should stay cautious and wait for clear signals before entering new positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




