Cautious market sentiment?

VN30 performance

The VN30Index posted its third consecutive gain, rising 0.42% to 1,317 points. VIC hit the daily limit-up and became the market's focal point. Capital flow also shifted into VJC (+6.18%), VNM (+3.55%), and MSN (+3.51%). On the other hand, selling pressure emerged in SSB (-2.69%), STB (-2.61%), and LPB (-2.12%).

VN30 Future chart: Cautious market sentiment?

On the daily chart, the contract extended its rebound but remained in a narrow trading range between 1,285 and 1,320 points, indicating a short-term consolidation phase. This reflects cautious sentiment among investors, especially as trading volume continued to decline.

Given current signals, a breakout is needed to confirm the next trend. The 1,320point level will serve as key resistance in the upcoming session, while the 1,280point area remains a strong support zone.

Technical strategy

Despite the third straight recovery session, market risk remains elevated. Therefore, traders should remain cautious, closely monitor market developments, and time their position entries carefully.



Figure 1. VN30 Generics daily chart





Figure 4. Open interest pattern




