# **Low liquidity**

### **VN30** performance

The VN30Index recorded its second consecutive correction session, declining 0.2% to 1,309 points. Selling pressure appeared on stocks such as SAB (-6.05%), VJC (-3.48%), BCM (-1.26%), and SSB (-1.08%). On the other hand, buying interest emerged mainly in VRE (+2.38%) and TCB (+1.15%).

### **VN30 Future chart: Low liquidity**

On the daily chart, the contract continued to consolidate, fluctuating within a narrow range of 1,285-1,320 points, signaling a short-term accumulation phase, especially as trading volume declined.

The contract needs a breakout session to confirm the next trend. The 1,320-point level will act as resistance in the next session, while the 1,300-point area remains a strong support zone.

#### **Technical strategy**

The contract continues to move within the narrow range of 1,285–1,320 points, so traders should remain cautious, closely monitor the market, and time their position openings appropriately.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




