Uptrend confirmed

VN30 performance

The VN30-Index extended its gains for a second consecutive session, reflecting positive investor sentiment. The index rose 1.99% to 1,351 points, with 28 out of 30 stocks advancing. Notably, VIC and GVR hit the ceiling price; in addition, capital flowed into PLX (+6.57%), BCM (+5.08%), FPT (+4.19%), MSN (+3.45%), LPB (+2.64%), and SHB (+2.38%). On the downside, only BVH (-0.20%) closed in negative territory.

VN30 Future chart: Uptrend confirmed

On the daily chart, the contract posted a breakout session, closing above key moving averages such as the 10-, 20-, and 50-period averages, especially as trading volume increased.

This development signals confirmation of a breakout from the prior consolidation pattern. With this breakout signal, the short-term price target is set in the 1,360-1,380-point range.

Technical strategy

The short-term uptrend has been confirmed alongside rising volume. Therefore, traders may consider maintaining or opening new long positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




