VN30 performance

The VN30Index posted its third consecutive gaining session, though the increase was modest. The index rose 0.09% to 1,352 points, with notable contributions from LPB (+4.39%) and FPT (+1.49%). On the downside, selling pressure appeared in VIC (-2.55%), PLX (-1.54%), and BVH (-1.43%).

On the daily chart, although there was a corrective session, the upward signal remained intact following the prior breakout session. In addition, the index continued to close above key moving averages, including the 10-, 20-, and 50-period averages, particularly as trading volume stayed at a high level.

Given the current signals, the uptrend may continue in the coming sessions, with the short-term price target set at the 1,360–1,380-point range.

Technical strategy

Despite the corrective session, the short-term uptrend has been confirmed. Therefore, traders may consider maintaining or opening long positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




