# **Testing the march 2025 peak**

## **VN30** performance

The VN30-Index recorded its fourth consecutive gaining session, rising 1.46% to 1,372 points. A total of 27 out of 30 index constituents advanced, with notable gainers including TCB (+6.52%), TPB (+4.98%), GVR (+4.88%), VIC (+3.79%), and BCM (+3.36%). On the other hand, selling pressure appeared in MSN (-1.27%) and HPG (-0.97%).

#### VN30 Future chart: Testing the march 2025 peak

On the daily chart, the contract has reached the target of the previous accumulation phase at the 1,360-1,380 zone. Trading volume continued to rise, accompanied by a long-bodied bullish candlestick, indicating a positive outlook for the current uptrend.

In addition, the index closed above key moving averages, including the 10-, 20-, and 50-period averages, confirming the current trend. The next major resistance zone is expected to be around 1,390-1,400 points.

### **Technical strategy**

The uptrend has been confirmed with a strong gaining session and rising volume. Therefore, investors may consider maintaining long positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




