Uptrend maintained

VN30 performance

The VN30-Index recorded its second consecutive gaining session, rising 0.84% to 1,419 points. The highlight was VHM, which hit its ceiling price. Additionally, capital flows were directed into STB (+5.82%), VIC (+2.19%), MSN (+1.44%), PLX (+1.44%), VPB (+1.37%), BVH (+1.21%), and SHB (+1.12%). On the other hand, selling pressure appeared in GVR (-1.44%) and LPB (-1.21%).

VN30 Future chart: Uptrend maintained

On the daily chart, the contract extended its gains and marked the second session breaking above the Mar 2025 peak. This signal indicates that the uptrend has been reaffirmed. Moreover, the contract continued to close above key moving averages, including the 10-, 20-, and 50-period lines.

The 1,360-1,380-point zone will serve as short-term support, while the next resistance level may lie near 1,420 points.

Technical strategy

With the second consecutive gaining session, the contract has reaffirmed the uptrend after breaking the Mar 2025 high. Therefore, traders may consider reopening long positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




