## **Market commentary**

#### **Divergent movements**

The market experienced a tug-of-war session as buyers and sellers alternated in dominance. However, selling pressure intensified toward the end of the session, pushing the market back into negative territory.

At the close, the VNIndex decreased by 0.06% at 1,347 pts. Meanwhile, the VN30Index increased to 0.11% to close at 1,432 pts. Intraday trading volume and value reached 851 million shares/VND20,313bn, down 3%/2%, respectively, compared to the average of the last five sessions.

Foreign were net selling, with more than VND277bn, focusing on FPT, STB, and VCI with net values of VN152bn, VND76bn, and VND59bn, respectively. In contrast, they focused net buying on HPG, MSB, and SHB with net values of VND192bn, VND97bn, and VND51bn, respectively.

Banking sector underperformed, led by VPB (-1.60%), LPB (-1.24%), VCB (-0.87%), VIB (-0.82%), TPB (-0.74%), BID (-0.70%), CTG (-0.50%), and SHB (-0.38%).

Brokerage sector also closed in red territory, including VND (-1.49%), SSI (-1.05%), and VCI (-0.83%).

Additionally, cash also outflowed into large-cap stocks, like FPT (-1.52%), MWG (-1.09%), SAB (-0.90%), MSN (-0.59%), VNM (-0.36%), and PLX (-0.13%).

On the other hand, Real Estate stocks gained, supported by VHM (+2.59%), VRE (+0.41%), VIC (+0.34%), and BCM (+0.17%).

The index ended the session almost flat, reflecting cautious investor sentiment following two strong gaining sessions. As the index approached the previous resistance zone around 1,350 pts without a corresponding liquidity breakout, it suggests that cash flow remains hesitant. Therefore, investors are advised to observe and wait for clearer market signals.
