Declining volume

VN30 performance

The VN30-Index recorded its second consecutive correction, falling 0.69% to 1,332 points. A total of 25 out of 30 stocks declined, with 15 dropping more than 1%. Key laggards included MWG (-3.42%), BCM (-2.57%), GVR (-2.38%), MSN (-2.21%), and VIB (-2.19%). On the other hand, only four stocks advanced, with notable buying interest in GAS (+1.56%), VIC (+1.44%), VHM (+0.91%), and HPG (+0.78%).

VN30 Future chart: Declining volume

On the daily chart, market sentiment remained cautious as the contract corrected after setting a new high in 2025. Additionally, declining volume confirmed this hesitation.

The contract still closed above key moving averages (MA10, MA20, and MA50), suggesting the short-term uptrend remains intact. However, risk remains elevated, and further confirmation signals are required.

The 1,400-point area remains a strong support level in the upcoming sessions, while the 1,420-1,440-point range acts as a strong resistance zone.

Technical strategy

Short-term risks increased as the contract declined on lower volume. Traders should stay cautious, monitor market developments closely, and wait for clearer signals before opening new positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




