The VN30Index recorded its third consecutive correction session, edging down 0.04% to 1,423 points. The index's component stocks showed divergence, with selling pressure appearing on VRE (-2.91%), MWG (-1.77%), and TPB (-1.13%). On the other hand, capital inflows were observed in PLX (+3.19%), VJC (+2.87%), STB (+2.70%), and GVR (+2.09%).

VN30 Future chart: Test the 10-period moving average

On the daily chart, the contract continued to decline and tested the 10-period moving average. While it managed to hold this level, selling pressure began to increase as trading volume started to pick up.

If the contract closes below the 10-period moving average, a downward trend may develop. However, this may also be a correction phase within a mediumterm uptrend.

The 1,400-point level remains a strong support zone in upcoming sessions, while the 1,420–1,440-point range will act as a notable resistance area.

Technical strategy

Short-term risks are increasing as the contract tests the 10-period moving average. Therefore, investors should remain cautious, closely monitor the market, and wait for further signals before opening new positions.







Figure 4. Open interest pattern


