## VN30 performance

The VN30Index recorded a strong gain of 1.37%, closing at 1,420 points. A total of 24 out of 30 constituent stocks advanced, led by oil and gas names as GAS and PLX hit their ceiling prices. Additionally, 16 stocks posted gains of more than 1%, including BVH (+4.67%), VPB (+3.58%), TCB (+3.53%), FPT (+3.12%), and SSI (+3.02%). On the downside, selling pressure was seen in VHM (-1.46%), VJC (-0.23%), VRE (-0.20%), and VIC (-0.12%).

## VN30 Future chart: Breakout session

On the daily chart, the contract posted a breakout session by surpassing both the 10-day and 20-day moving averages, suggesting the prior correction phase may have come to an end.

However, declining trading volume implies that risks remain, and investors should stay cautious and wait for further confirmation in today's session to validate the potential return of an upward trend.

In the near term, the 1,380-point level remains a strong support zone, while the 1,400–1,420-point range is expected to act as a notable resistance area.

## **Technical strategy**

An upward trend may be re-emerging following yesterday's breakout session. However, investors are advised to await additional confirming signals in the coming sessions before reopening long positions.



Figure 1. VN30 Generics daily chart





## Figure 2. Basis spread





#### Figure 4. Open interest pattern




