Sustaining upward momentum

VN30 performance

The VN30Index recorded its second consecutive gain, rising by 0.78% to 1,431 points. Notably, capital inflows were seen in VHM (+3.26%), GVR (+3.21%), VIC (+2.69%), LPB (+2.21%), MSN (+1.65%), TPB (+1.50%), STB (+1.10%), and VCB (+1.06%). On the contrary, selling pressure emerged in PLX (-3.10%) and VIB (-0.55%).

VN30 Future chart: Sustaining upward momentum

On the daily chart, the contract continued to show positive signals as it closed above the 10-period moving average for the second consecutive session, suggesting a potential continuation of the upward trend.

However, trading volume remains low, and with the contract set to expire in the next two sessions, short-term risks still persist.

In the upcoming session, the 1,400-point area will serve as a strong short-term support level, while the 1,420-1,440-point zone will act as notable resistance.

Technical strategy

Short-term risks remain elevated with the contract approaching expiration. Therefore, traders are advised to remain cautious and wait for further confirmation signals in the coming sessions before reopening long positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




