Breakout above previous high

VN30 performance

The VN30Index recorded its fourth consecutive gaining session, testing the June 2025 peak, with a 0.44% increase to 1,439 points. Capital inflows were observed in TCB (+3.66%) and GVR (+3.10%), along with six other stocks gaining over 1%, including VIC, LPB, PLX, CTG, GAS, and SSI. On the other hand, selling pressure emerged in BVH (-1.16%) and SHB (-1.14%).

VN30 Future chart: Breakout above previous high

On the daily chart, the contract posted a breakout session, surpassing the previous early-June high. Although volume did not increase, this movement is sufficient to confirm that the uptrend has returned.

Risk has also subsided as the contract has passed its expiration. In the upcoming sessions, the 1,400-point zone will serve as strong short-term support, while the 1,450-1,480 zone will be a key resistance area.

Technical strategy

The breakout session confirms that the uptrend has resumed. Therefore, traders may consider reopening long positions in the coming sessions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




