# **Continued caution**

## **VN30** performance

After three consecutive correction sessions, the VN30Index recorded a slight decline of 0.12% to close at 1,463 points. Selling pressure emerged on VHM (-2.44%), GVR (-0.97%), and VIC (-0.84%), while buying interest was seen in MSN (+2.42%), GAS (+1.48%), and MBB (+1.17%).

#### **VN30 Future chart: Continued caution**

On the daily chart, the contract continues to exhibit cautious sentiment, fluctuating around the 2025 peak zone. However, current signals still imply a positive outlook, as the recent correction is likely part of a consolidation phase, indicated by declining trading volume.

Moreover, the contract remains above the 10- and 20-period moving averages, suggesting the short-term uptrend is intact. The 1,400-point level serves as strong short-term support, while the 1,450-1,480-point range remains a notable resistance zone.

### **Technical strategy**

Despite short-term volatility, the long-term uptrend remains intact. Therefore, traders are advised to monitor the market closely and wait for appropriate signals to reinitiate long positions in the upcoming sessions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




