

Rising liquidity

VN30 performance

The VN30Index posted a slight decline of 0.11%, closing at 1,481 points. The correction was driven by losses in GVR (-5.28%), BCM (-2.64%), STB (-1.89%), and VJC (-1.33%). On the other hand, buying interest emerged in CTG (+1.43%), HDB (+1.12%), and TPB (+1.10%).

VN30 Future chart: Rising liquidity

On the daily chart, the contract returned to a consolidation phase as the price remained nearly unchanged in the latest session. While trading volume increased, there was no strong breakout to confirm the resumption of the short-term uptrend. Therefore, further confirmation is still needed.

The long-term uptrend remains intact as the contract continues to close above the 10- and 20-period moving averages. The 1,400-point level serves as strong short-term support, while the 1,450–1,480 zone remains a key resistance area.

Technical strategy

The contract is currently in a consolidation phase and needs additional signals to confirm a short-term uptrend. As such, investors should monitor the market and wait for clearer signals before re-entering long positions in the upcoming sessions.

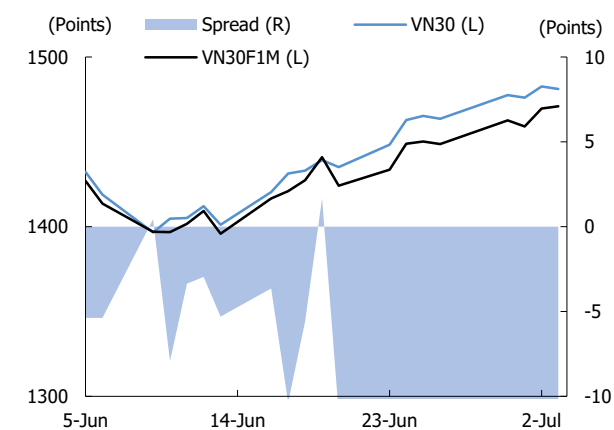

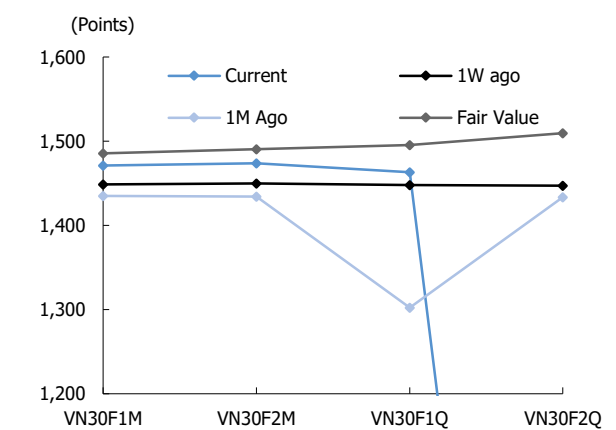

Figure 1. VN30 Generics daily chart

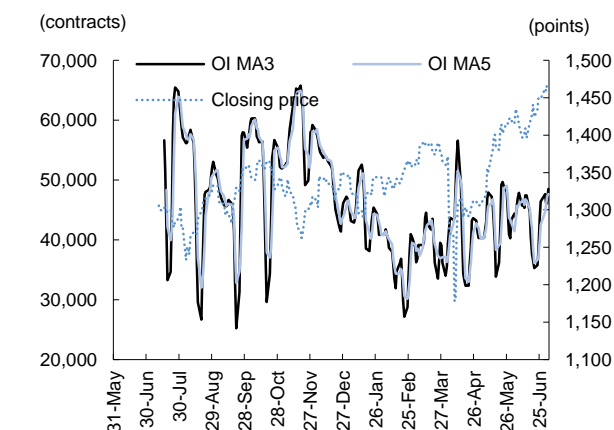

Figure 2. Basis spread

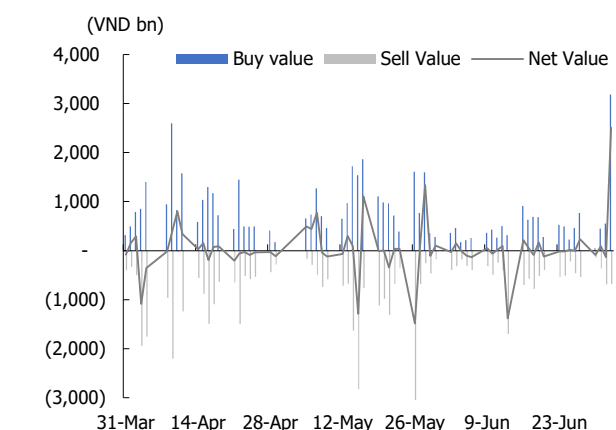
