# **Profit-taking pressure**

## **VN30** performance

After three consecutive gaining sessions, the VN30Index posted a correction, declining 0.96% to 1,628 points. Selling pressure was primarily concentrated on VIC (-5.88%), VHM (-4.17%), TCB (-2.21%), and MSN (-2.02%). In contrast, buying interest emerged in VPB (+4.45%), SHB (+2.82%), and LPB (+2.60%).

### **VN30 Future chart: Profit-taking pressure**

On the daily chart, although a correction occurred, the long-term uptrend remains intact as the contract continues to close above the 10-day and 20-day moving averages. As such, the uptrend is likely to persist.

However, in the short term, the contract may experience some volatility, as the recent rally has yet to undergo a sufficiently long correction phase. This suggests a need for a technical consolidation. The short-term support level is around 1,600 points, while the 1,650-point zone is expected to act as resistance.

#### **Technical strategy**

The risk of a technical pullback is increasing. Therefore, investors may consider staying on the sidelines for now and wait for more favorable entry points.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




