New high formed

VN30 performance

The VN30Index resumed its uptrend, gaining 0.49% to close at 1,669 points. Capital flows continued to focus on VJC (+6.9%), SSI (+6.3%), SSB (+3.8%), HDB (+2.4%), VPB (+2.3%), VHM (+1.8%), and ACB (+1.7%). On the other hand, selling pressure appeared in VIC (-1.6%), GVR (-1.4%), and VRE (-1.0%).

VN30 Future chart: New high formed

On the daily chart, the contract continued its upward momentum with a breakout session, confirming a new high for 2025. Although trading volume did not increase, it has not negatively impacted the current uptrend.

While the uptrend remains intact, the risk of short-term volatility persists, as the recent rally has yet to experience a meaningful correction. This suggests that a technical consolidation may be necessary. The short-term support level is around 1,600 points, while the 1,680–1,700 range is expected to act as resistance.

Technical strategy

With the uptrend confirmed, traders may consider maintaining their long positions. However, as the risk of a trend reversal increases, traders should be ready to exit positions quickly if negative signals emerge in upcoming sessions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




