Market commentary

Extending the uptrend

The market continued its positive upward momentum as the index set new highs, despite intraday volatility when temporary selling pressure briefly pushed it into negative territory.

At the close, the VNIndex increased by 1.24% at 1,547 pts. Meanwhile, the VN30Index increased to 2.25% to close at 1,690 pts. Intraday trading volume and value reached 2,809 million shares/VND78,253bn, up 56%/63%, respectively, compared to the average of the last five sessions.

Foreign were net selling, with more than VND2,339bn, focusing on VIC, SHB, and VPB with net values of VND2,668n, VND231bn, and VND199bn, respectively. In contrast, they focused net buying on HPG, MSN, and BID with net values of VND1,083bn, VND140bn, and VND140bn, respectively.

Banking stocks recorded gains, led by MBB (+6.83%), TPB (+5.07%), TCB (+4.67%), STB (+3.40%), CTG (+1.86%), BID (+1.84%), LPB (+1.73%), VCB (+0.65%), ACB (+0.64%), and VPB (+0.38%).

Brokerage stocks delivered strong returns, including VCI (+2.58%), VND (+1.94%), SSI (+1.91%), and MBS (+0.28%).

Real Estate stocks closed in the green, such as VRE (+6.36%), VIC (+5.67%), VHM (+4.12%), KBC (+2.85%), and SSH (+0.66%).

Additionally, cash also flowed into other large-cap stocks including HPG (+4.35%), MWG (+3.43%), MSN (+0.95%), DGC (+0.29%), and GVR (+0.17%).

The market experienced intraday swings as the index approached new highs, but persistent buying demand helped it regain positive territory by the close. Meanwhile, improving liquidity signaled that the uptrend remains intact, keeping overall market sentiment positive. Hence, investors may consider opening partial long positions in their portfolios.
