# **Downtrend slowing**

#### **VN30** performance

The VN30-Index experienced high volatility during the session, but late-session buying support helped the index avoid a steep decline. As a result, the index edged down 0.07% to close at 1,614 points, with selling pressure concentrated in CTG (-3.49%), SSI (-2.92%), BCM (-2.51%), and VIB (-2.06%). On the other hand, buying interest emerged in FPT (+2.88%), HDB (+2.08%), BVH (+1.52%), VRE (+1.25%), and SHB (+1.16%).

### **VN30 Future chart: Downtrend slowing**

On the daily chart, the contract showed signs of recovery, supported by strong buying near the 20-day moving average. In addition, the decline in trading volume is a positive signal, suggesting that selling pressure may be easing in the short term.

Although the downtrend may continue for the next few sessions, this consolidation phase could end soon as demand remains strong at lower price levels and the longer-term uptrend remains intact. Therefore, it is important to continue monitoring for potential reversal signals in the coming sessions.

#### **Technical strategy**

The late-week rebound provides a positive signal for the market outlook. As such, investors should closely monitor the market and wait for appropriate opportunities to initiate long positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




