Uptrend maintained

VN30 performance

The VN30-Index recorded its fourth consecutive gain, rising 0.67% to close at 1,734 points. The spotlight was on TPB and VPB, both of which hit the daily limit-up. Additionally, capital inflows were observed in HPG (+5.17%), GVR (+2.81%), and BID (+2.41%). On the other hand, selling pressure emerged in VIC (-2.95%), VHM (-2.56%), VJC (-1.01%), and SSB (-1.00%).

VN30 Future chart: Uptrend maintained

On the daily chart, the contract continued to confirm its short-term uptrend by forming a new high. Furthermore, it closed above both the 10-day and 20-day moving averages, reinforcing the ongoing upward momentum.

However, a short-term pullback may occur, as the recent candle showed a small body and decreasing volume, indicating slowing momentum. Still, any potential pullbacks should be viewed as a consolidation phase within the broader uptrend.

Technical strategy

Given the current signals, the contract remains in an uptrend. Therefore, traders may consider reopening long positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




