A downtrend

VN30 performance

The VN30Index recorded its third consecutive corrective session as selling pressure persisted. Accordingly, the index corrected sharply by 1.17% to 1,924 points, with 26 constituent stocks declining. Selling pressure emerged on VJC (-4.37%), VPB (-2.93%), VNM (-2.54%), and VHM (-2.32%). Additionally, 9 other stocks corrected by over 1%. On the opposite side, buying interest appeared on SAB (+1.55%), LPB (+0.68%), and FPT (+0.42%).

VN30 Future chart: A downtrend

On the daily chart, the market sent negative signals with three corrective sessions. Additionally, the contract closed below the 10-period and 20-period moving averages. This suggests confirmation that the downtrend may have returned.

Although the contract still held the 1,900-point level and the 50-period moving average, the sharp decline in the previous session accompanied by increased volume suffices to confirm a short-term downtrend.

In the next session, the 1,980-2,000 point zone will serve as strong resistance, while the 1,900-1,920 point zone will represent important support.

Technical strategy

The short-term downtrend receives confirmation with increasing volume. Therefore, traders should exercise caution and may consider opening short positions.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 4. Open interest pattern




