A Downward Trend?

VN30 performance

The VN30Index experienced its second consecutive adjustment session, declining 0.38% to 2,066 points. Accordingly, selling pressure emerged on VPB (-3.42%), STB (-3.18%), HDB (-3.13%), VRE (-2.51%), MSN (-2.30%), and VJC (-2.12%). On the opposite side, buying interest appeared on BID (+6.97%), VCB (+6.75%), CTG (+6.68%), GAS (+6.00%), GVR (+5.16%), BCM (+4.11%), and PLX (+3.61%).

VN30 Future chart: A Downward Trend?

On the chart, the market continued its correction with increased volume. This implies a negative signal regarding the possibility that a downward trend may be confirmed.

However, additional signals remain necessary to confirm the current trend, as some indicators still support an upward trend. Accordingly, the contract still closed above the 10, 20, and 50-period moving averages. Moreover, after a breakout session occurs, the appearance of a few correction sessions represents a normal phenomenon.

In the next session, the 2,100-point threshold will serve as strong resistance, while the 2,040-2,050 point zone will provide strong support.

Technical strategy

The signals lack uniformity regarding the current trend. Therefore, traders need to exercise caution and wait for confirmation signals before opening new positions.

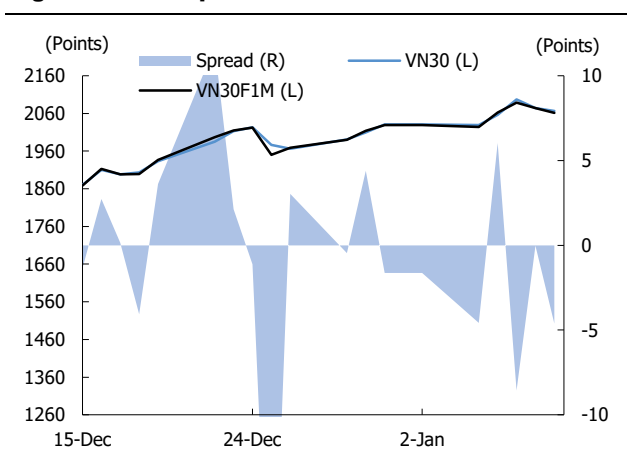

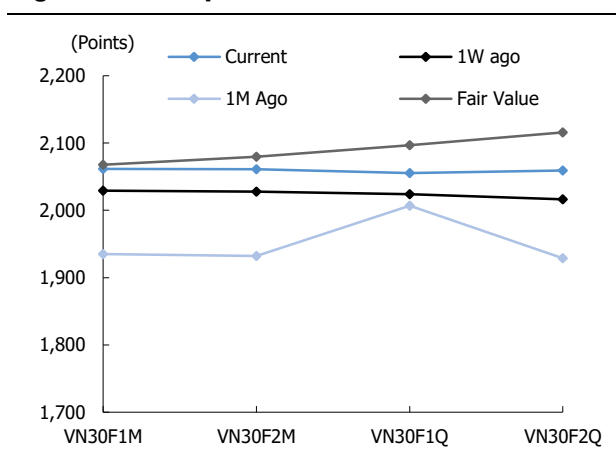

Figure 1. VN30 Generics daily chart

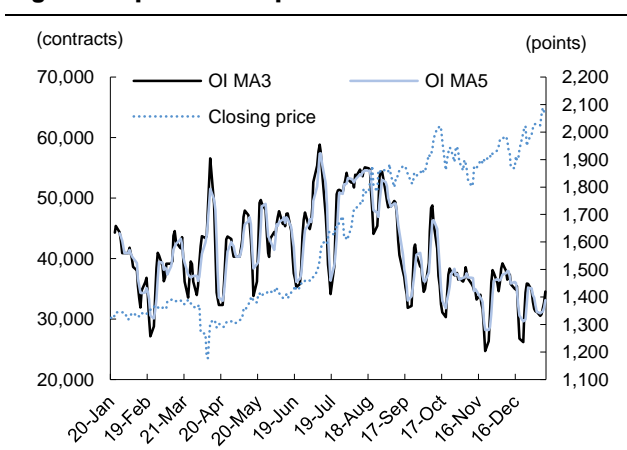

Figure 2. Basis spread

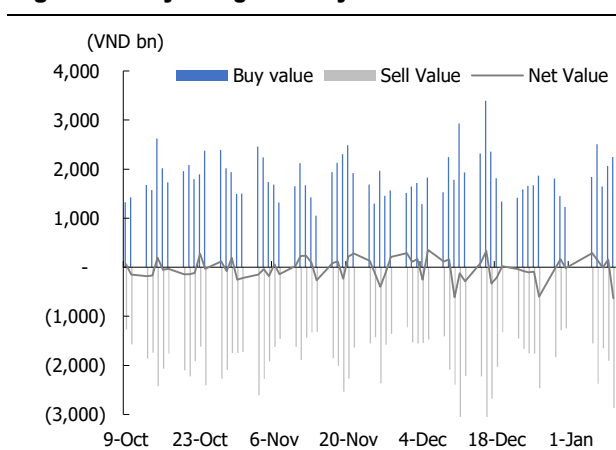
