## A cautious stance

### VN30 performance

After two consecutive adjustment sessions, the VN30Index recorded a growth session, though the increase remained modest with a recovery of 0.09% to reach 2,082 points. The spotlight fell on DGC as this stock hit the ceiling price. Additionally, capital flowed into STB (+2.25%), VRE (+1.92%), SSB (+1.72%), GVR (+1.30%), MWG (+1.29%), and TPB (+1.16%). On the opposite side, selling pressure appeared on GAS (-4.73%), PLX (-4.40%), VCB (-2.47%), and BCM (-2.36%).

### VN30 Future chart: A cautious stance

The contract still closed above the 10, 20, and 50-period moving averages. This implies that the upward trend remains intact in the short term. Notably, the contract receives support around the 10-period moving average with volume maintained at high levels.

However, investors need to monitor confirmation signals regarding the trend before reopening positions, as selling pressure persists. The contract tests the previous historical peak zone (the 2,090-2,100 point range) and continues to fluctuate within a narrow range. Therefore, a breakout session proves necessary to demonstrate that the upward trend will continue.

In the next session, the key support level stands at the 2,020-2,050 point zone, which coincides with the 20-period moving average. Meanwhile, the resistance level stands at the 2,100 point zone.

### Technical strategy

Despite multiple positive signals, investors need to monitor additional signals to confirm the trend. Therefore, traders should exercise caution and observe further signals before reopening positions..

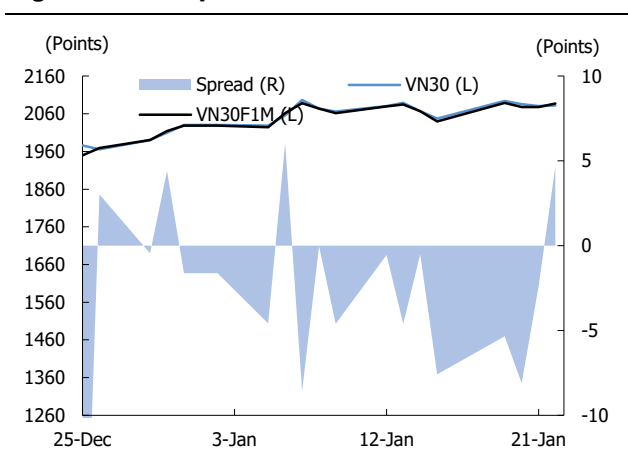

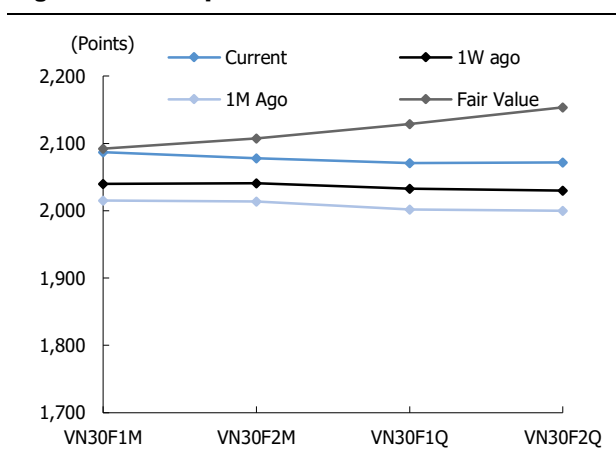


**Figure 1. VN30 Generics daily chart**

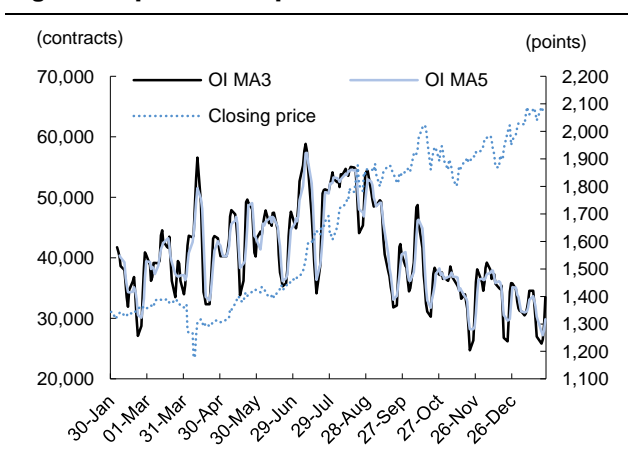

**Figure 2. Basis spread**

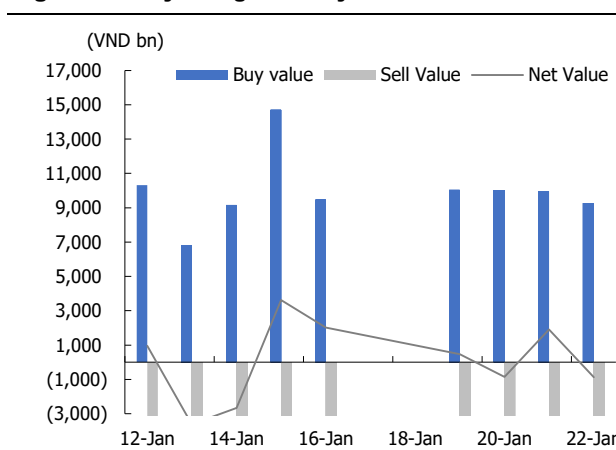
