## Sell signal?

### VN30 performance

The VN30Index experienced a sharp correction of 2.19% to 2,032 points, with the spotlight on DGC, as this stock hit the floor price. Additionally, selling pressure also appeared on VJC (-5.99%), VRE (-4.32%), HDB (-4.22%), SHB (-3.37%), VIC (-3.33%), and MBB (-3.15%). On the opposite side, buying interest emerged in GAS (+6.94%), GVR (+4.74%), and PLX (+4.40%).

### VN30 Future chart: Sell signal?

The contract shows a sell signal as it closed below the 10 and 20-period moving averages. Additionally, volume remains at high levels; therefore, a downward trend may be forming.

Although the contract still closed above the 50-period moving average, selling pressure has emerged; therefore, the possibility of testing the 1,980-2,000 point zone in upcoming sessions may occur.

The previous accumulation phase remains intact with the upper boundary at the 2,090 point threshold and the lower boundary at the 2,030 point threshold. If a breakout signal appears, the contract may experience strong volatility.

### Technical strategy

The downward trend receives confirmation in the short term. Therefore, traders may consider opening short positions and taking advantage of recovery waves to maximize profits.

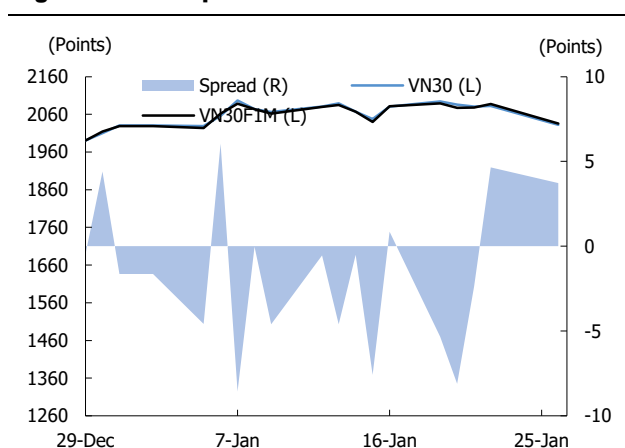

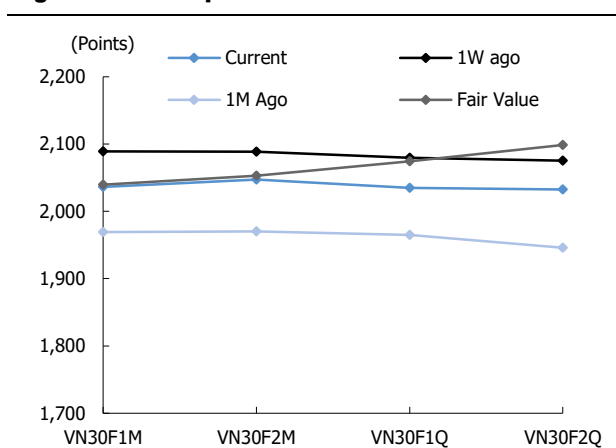

**Figure 1. VN30F1M Generics daily chart**

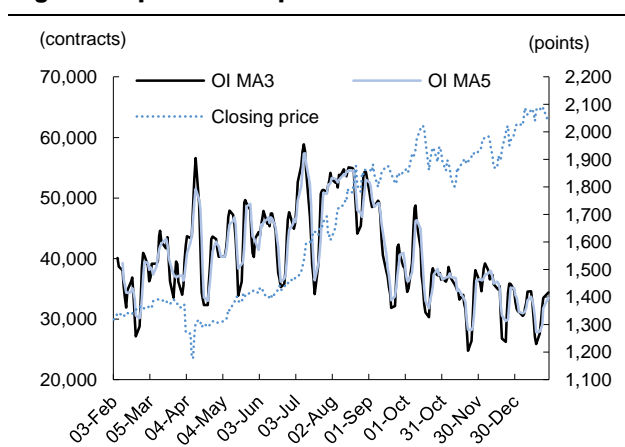

**Figure 2. Basis spread**

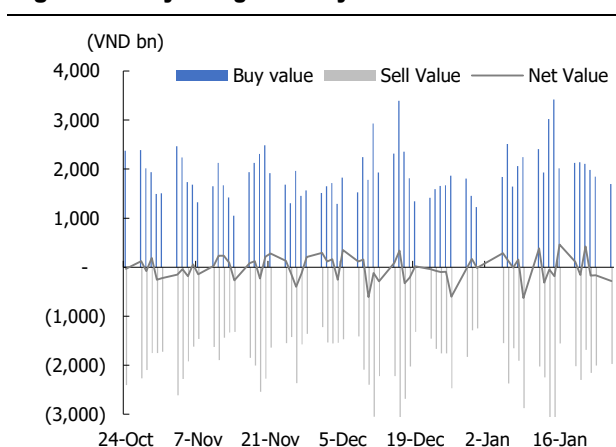
