# Declining liquidity

## VN30 performance

The VN30Index recorded its fourth consecutive growth session, with the index gaining 0.78% to 2,016 points. Accordingly, capital concentrated in VHM (+5.83%), VIC (+5.44%), VRE (+1.87%), and MWG (+1.09%). On the opposite side, selling pressure persisted on MBB (-2.24%), BID (-1.96%), TPB (-1.15%), and DGC (-1.02%).

## VN30 Future chart: Declining liquidity

Optimistic sentiment stalled as the contract approached the 10-period moving average, showing the need to observe additional signals to confirm the return of the upward trend.

The signals lack consistency as both positive and negative signals continue to appear. On the positive side, the contract closed above the 20 and 50-period moving averages, implying confirmation of an upward trend. However, on the opposite side, the upward momentum stalls and liquidity declines. Therefore, additional signals remain necessary to confirm the upcoming trend.

In the next session, the 2,050 point threshold will serve as strong resistance in the short term, while the 1,940-1,950 point zone will serve as strong support.

## Technical strategy

The signals lack consistency and the Lunar New Year holiday approaches; therefore, caution remains necessary with the current trend. Traders should exercise caution, observe the market, and wait until after the holiday to reopen investment positions.





**Figure 1. VN30F1M Generics daily chart**



**Figure 2. Basis spread**


