Market commentary

Afternoon selling pressure

Although buying demand appeared during the session, dominant selling pressure pushed the index to reverse and move back into negative territory. Nevertheless, the Real Estate sector maintained positive performance, with several stocks posting gains.

At the close, the VNIndex decreased by 0.78% at 1,696 pts. Meanwhile, the VN30Index decreased to 0.33% to close at 1,853 pts. Intraday trading volume and value reached 1,024 million shares/VND24,465bn, down 13%/21%, respectively, compared to the average of the last five sessions.

Foreign were net selling, with more than VND416bn, focusing on BSR, VIC, and SSI with net values of VND286bn, VND133bn, and VND99bn, respectively. In contrast, they focused net buying on KDH, VNM, and MSN with net values of VND141bn, VND139bn, and VND133bn, respectively.

The Banking sector declined, led by VCB (-1.34%), CTG (-0.87%), HDB (-0.39%), VPB (-0.39%), MBB (-0.38%), TPB (-0.31%), and BID (-0.25%).

The Brokerage sector underperformed, including TCX (-6.87%), SSI (-2.57%), VIX (-2.08%), VND (-1.81%), HCM (-1.37%), and VPX (-0.97%).

Additionally, capital outflows were observed in several large-cap stocks such as GAS (-6.99%), PLX (-6.92%), GVR (-5.03%), DGC (-4.33%), MWG (-3.07%), VRE (-2.51%), VPL (-1.25%), FPT (-0.90%), CTG (-0.87%), HPG (-0.56%), and VIC (-0.28%).

On the other hand, the Real Estate sector posted gains, including NVL (+6.75%), VHM (+2.19%), and KDH (+1.56%).

The market recorded a declining session while liquidity remained low, suggesting that selling pressure was not overly strong but capital flows remained cautious. In addition, the intraday fluctuations reflected a tug-of-war between buyers and sellers, as buying demand appeared at certain points but was not strong enough to reverse the trend. This development implies that the market is still in a testing phase and may continue to experience volatility in the upcoming sessions.

► Market performance

The market continued its correction for the second consecutive week of decline. Investors expressed concern that the ongoing conflict in the Middle East could impact the Vietnamese market.

The short-term downtrend was confirmed as the VN-Index closed below most key short-term moving averages, including the 10-period, 20-period, and 50-period MAs. In addition, the 10-period MA crossed below the remaining averages.

However, an accumulation phase emerged in the previous week, as the index staged a strong recovery mid-week before momentum faded over the final two sessions - notably with declining liquidity and small-bodied candlesticks. This implies hesitation in investor sentiment. Therefore, additional signals are needed to confirm the short-term trend direction.

A variation of a double-top pattern was confirmed, with peaks established in January and March 2026. The price target of this pattern stands at 1,550–1,570 points. This week, the 1,700-point level will serve as strong resistance, while the 1,650-point level will act as strong support.

→ An accumulation trend emerged alongside declining liquidity. Signals this week therefore require close monitoring to confirm the market's next directional trend.

► Technical strategy: Awaiting a reversal signal

In this scenario, investors are advised to exercise caution, observe the market carefully, and wait for an uptrend to be confirmed before opening new positions.
