Downtrend confirmed

VN30 performance

The VN30 Index recorded its third consecutive declining session, falling sharply by 3.03% to close at 1,797 points. 27 constituent stocks declined, with PLX, GAS, and DGC as the focal points - all three hit their floor price limits. Selling pressure also extended to VIC (-6.90%), LPB (-6.38%), MSN (-5.44%), and GVR (-5.24%). On the positive side, buying demand appeared only in VRE (+0.38%).

VN30 Future chart: Downtrend confirmed

Sell signals re-emerged as the contract formed a long red candlestick body accompanied by rising volume during the end-of-week trading session - a development that confirmed the short-term downtrend.

Furthermore, the contract closed back below the 10, 20, and 50-period MAs, while the 10-period MA remained below both the 20-period and 50-period MAs. The current downtrend is therefore expected to persist in the period ahead.

For the next session, the 1,900-point level will serve as strong short-term resistance, while the 1,800-point level will act as a key support zone.

Technical strategy

The downtrend has been reconfirmed, supported by rising volume. Traders may consider opening short positions in upcoming sessions, and can take advantage of short-term recovery rallies to optimize returns.



Figure 1. VN30 Generics daily chart





Figure 2. Basis spread





Figure 3. Future price curve




