Market commentary

Extending the uptrend

The market continued its positive performance, with gains being extended. Notably, the Real Estate sector stood out with many strong advancers, playing a leading role in driving the market.

At the close, the VNIndex increased by 1.41% at 1,800 pts. Meanwhile, the VN30Index increased to 0.77% to close at 1,961 pts. Intraday trading volume and value reached 951 million shares/VND28,331bn, down 6%/ up 5%, compared to the average of the last five sessions.

Foreign were net selling, with more than VND3,505bn, focusing on VHM, FPT, and STB with net values of VND3,374bn, VND432bn, and VND87bn, respectively. In contrast, they focused net buying on VIC, VCB, and SSI with net values of VND372bn, VND64bn, and VND61bn, respectively.

Real Estate sector closed in positive territory, led by VIC (+6.95%), VHM (+6.28%), VRE (+5.02%), NVL (+2.34%), and KDH (+1.34%).

Additionally, capital flowed into large-cap stocks such as VJC (+6.83%), VPL (+5.00%), SAB (+2.21%), and GVR (+0.92%).

On the downside, the Brokerage sector declined, including VCK (-1.63%), TCX (-0.95%), VCI (-0.89%), and VND (-0.30%).

Banking sector underperformed, with STB (-2.72%), VIB (-1.42%), ACB (-0.83%), LPB (-0.63%), TCB (-0.62%), SSB (-0.59%), MBB (-0.37%), TPB (-0.30%), and BID (-0.25%).

The short-term uptrend continues to strengthen as the market maintains its upward momentum, indicating that buying demand still dominates and investor sentiment is gradually improving. This suggests that the index may continue to perform positively in the coming sessions, and if capital inflows increase more clearly, the uptrend will be reinforced with greater reliability.
